"Fluidice": Living Information Within Mass Structure

Abstract:-In previous papers, [1] the existence of an additional energy to the electromagnetic has been described and designated as [fluidice//traction fluidice]. This living energy operates to transduce information into the electromagnetic, molecular continuum from a more topological matrix of non-local information. The concept is introduced in this paper that enhancement of the interdimensional cognition process can be achieved by developing a specific device to be attached to the organic brain/body system rather than by placing the brain/body system in any specific chamber or enclosed area. Concepts of cyber animation by fluidice robotics are also discussed.

1.Introduction

The generic image of a "new communications device" is one which sends a signal, thus altering events at a receptor site. The emphasis is on the signal propagation. The "fluidice enhancement" devices aim to alter the living, neural receptor primarily so that subtle effects of the mental/material energies can be more fully realized, both in reception and transmission.

The living organism is regarded as the generator of a palpable energy [traction fluidice] which powers the density shift of linked, molecular nuclei. On the other hand, the action of the traction fluidice is provoked by a configuratrional energy coding which does not enter the electromagnetic, molecular system.

In order to enter the material, four dimensional spacetime (which is sine-function, linear dependent) the Intelligence or logos of an event must in some way provoke the coparticipation of a living "traction fluidice" generator. The concept of contingency and context is extremely important .in understanding the actual action of "fluidice". For since this energy is a "living energy" it is vitally dependent upon context, as a living endocrine, cellular fluid or blood/sap is manifest only in context of the larger organic structure it facilitates.. When a molecular structure supported by fluidice organization loses coherent context, the individual nuclei of the atoms are no longer in coherent transduction contact with the "fluidice" matrix. This structure then dies or explodes.

In reverse, when the atomic structuring is suddenly released from molecular coherence by atomic fusion/fission this material shift of the atomic nuclei and orbitals will have an effect on the configurational energy of the "fluidice" matrix which is non-local and nonchronologically sequential Thus, actions which de-phase coherent atomic -molecular positioning have a type of result which is registered "outside" the sequential molecular pulsing by which we measure mundane time.




Fig.1 non-local effects from atomic fission/ fusion via fluidice matrix transduction

In principle., a materiallyentangled subtle energy event can code both past and future non-local events by transduction through the fluidice information matrix. In this situation, the action is of a sudden "taking shape" rather than a linear "push" into transformation. This "taking shape" is an instant, simultaneous and co-active shift within each fluidice-linked timespace region. So that the changes of past, present and linear future occur as parts of the same information-shape in the extratemporal continuum. 2.1 Problem Formulations

In the past, efforts toward making an "orgone cabinet" and tetrahedral "pyramid power" enclosures to reliably induce healing and/ or other physiological mind/neural transformations have not been uniformly successful. A chamber with walls at any arbitrary angles, grasping within these boundaries a limited area of three dimensional space, cannot actually duplicate the "naturally-occurring time chamber" effects since the assumption is incorrectly that the shape of the chamber will fit anywhere into contextual space and that what matters to the operation is only what goes on "inside" the chamber.

But this view does not take into account the naturally variable quality of gravitation and thus mass inertia and structural subtle energy inter-linkage wherever the invariably-shaped artificial chamber might be placed. Rather than studying the arcane nature of planes and angles in this context, it makes more sense to study neural and mental/material organic effects which occur within the "earth chackra" areas in order to duplicate these conditions within the individual human body. It is the mind/body system of the individual which may then be traveling through a number of different material/multidimensional environments and contexts.

Further, such an enhancement of function will act to cause the subtle alteration of the environment of the individual via the "fluidice transduction" process. So rather than simple limitation of the shape of the near environment to cause healing (hopefully, not hexing) the artificial enhancement of the individual's neural transduction process causes an increased telekinetic access to the [fluidice//traction fluidice] matrix which controls non-linear/local (and/or also linear/local) causality.

2.2 Examples

One mundane example of this effect is the spoon-bending parties [2] during which the participants either bend or do-not bend spoons according to their own mental/neural orientation and are not observed to be uniformly similar in response. The energy which causes the bending flows through their individual organic mechanisms and is not located "in the air" about them. This energy seems to be transmitted from person to person by a form of non-local mental/emotional osmosis of subtle energy.




Fig.2 toxic environment vs live contagion = limited area fluidice activation vs info-seed diaspora

This subtle energy induction is more like viral or bacterial contagion than four-dimensionally limited toxic contamination. During chemical contamination, a toxic substance introduced into a specific timespace area can cause universally predictable symptoms in the organic and inorganic objects and lifeforms within that limited area. But an individual subject to subtle energy enhancement may or may-not show symptoms of this enhancement whilst within the exact local area of timespace designated "party area" or "magic circle" Evidence of this enhancement may occur earlier or later and not at all within the designated four dimensional party/meeting situation. As when a micro-organism can lie dormant within the organic system, and/or is more effective within certain systems than other systems. It also makes sense to think in this context of the concept of "vaccination". An individual previously exposed to positive subtle energy transfer is less likely to accept within the mind/body system a transfer of detrimental subtle energy. A mundane analogy to this "live energy vaccination" concept is the truth that "once burned//twice shy". Once startled by actual subtle energy transfer, the individual naturally develops a protective subtle awareness of such possibilities.

2.3 Fluidice Micro-Seed

Several venerable religious philosophies such as the Parsi (Zoroastrian) and pre-Socratic teachings of the Greek Heraclites have compared the atomic subtle energy development to a seed. The planting of a seed is quite different from the growth of the final organism. The mature organism is not instantly developed but is at any one instant entirely patterned by the DNA growth directions of the seed. Of course, this basic pattern will also be affected by environment. Particularly if there is atomic fusion in the event space of the seed.

The "fluidice" model is somewhat similar to this "seed" conception in that the [fluidice//traction fluidice] array is assumed to be living substance embodying coherent, dynamically intelligent patterning.

3.Problem Solution

How become more aware of such possible signals? The obvious answer is not simply to alter the small area of a cubicle or pyramid or other hollow geometric solid which might be used by a number of people with different interdimensional specifics. Since the brain/body system is the organic sensing mechanism for the mind, the device for enhancement of individual perception/action as far as incarnate Intelligences are concerned, should involve alteration of signal reception at the neural synapse. 




Fig.3 The synapse spark gap: fluidice transduction in neurotransmitter fluid

Thus, in extraordinary or healing circumstances, it does seem that there is documented a reference matrix [fluidice//traction fluidice] which receives information and coordination of the organic shift independently of the material signal conductance of the brain. Then, how does the brain, whose neural quality is known medically to be different from the chemical and neural quality of the body, access this "fluidice" matrix sans molecular neural reflex? It must be that there is a materially-entangled information transduction protocol by which this is done.

4. Conclusion

In medical history, there are accounts of people who have functioned normally[4] without a full brain or with only cerebrospinal fluid in the brain cavity. This fact indicates that the cerebrospinal fluid contains the type of atomic nuclei which materially interact with the fluidice transduction matrix Possibly the neurotransmitter fluid at the neural synapses in the body also has this fluidice transduction facility at the atomic nucleus. Detailed structural analysis of these two types of bodily fluid might yield some very indicative results. The structure of hemoglobin in the blood of humans and animals has a similar structure to the chlorophyll molecule in plants.[5] But this molecular structure is concerned with the catalysis of oxygen and carbon dioxide within the organic tissue-not with electromagnetic signal transfer. The catch word "blood/brain barrier" refers to the fact that the brain itself is not nourished directly by blood as are the bodily tissues. If this transduction by cerebrospinal fluid of the [fluidice//traction fluidice] energies of life is approximately the case, then the ancient practice of necromancy makes primitive sense.
